

**Omron Write A Review Sweepstakes  
Official Rules**

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** The Omron Write A Review Sweepstakes (“Promotion”) is open only to legal residents of the United States and the District of Columbia who are 18 years of age or older as of date of entry. Employees of Omron Healthcare, Inc. **HOW TO ENTER:** During the Promotion Period, visit OmronHealthcare.com and visit a product page. Then, click the “Write a review” link and follow the instructions to complete the provided entry form and post your own original product review to receive one (1) entry into the applicable Monthly Period. **Note: Reviews submitted will not be judged and will therefore not increase or decrease your chances of winning a prize.** To enter this Sweepstakes without writing a review, fill out the entry form on the sweepstakes webpage on the Omron Healthcare website [omronhealthcare.com/win](http://omronhealthcare.com/win). Entries must be received by the last day of an applicable Monthly Period to be eligible for such Monthly Period drawing. Entrants may enter a new review as often as they like HOWEVER only one (1) prize per person during the Promotion Period will be awarded.
